**DEVELOPMENT PLANNING ACT, 2016
(ARTICLE 57)**

Revision of Scheduling of Property

WITH reference to Government Notice No. 349 (Government Gazette No. 17,086 of 20th April, 2001) and No. 629 (Government Gazette No. 18,283 of 21st July, 2008), the Planning Authority declares that it is re-scheduling a property within the list of scheduled properties, in terms of Article 57, and 97 to 100 of the Development Planning Act, 2016, and paragraphs 1.13, 2.27, and policies TO8, UO2 and RO4 of the Strategic Plan for the Environment and Development (SPED).

The following revisions (as shown on the map on page 4095) are being published: Villa Frere and Gardens, originally scheduled as Grade 2, is now being scheduled as Grade 1, and the staircase of the Tempietto is being scheduled as Grade 1.

On 10th of March, 2020, the Executive Council endorsed the re-scheduling of this property.

The Planning Authority will exercise its powers of enforcement, as set out in Article 57, and 97 to 100 of the Act, in the case of any contravention to the provisions of the Development Planning Act 2016 as regards to Scheduled Property.
